## Building affordable housing

- Secured financing for Near Westside Apartments, 26 units of affordable family rental housing in the Brown Street and Fulton Avenue neighborhoods of the City of Rochester, to be constructed in 2002, from the City of Rochester and the New York State Division of Housing and Community Renewal.
- Secured partial funding for Hickey Commons, affordable apartments for seniors in Macedon, Wayne County, from the Affordable Housing Program of the Federal Home Loan Bank of New York through member bank HSBC.

## Promoting homeownership

- Enrolled first clients in the Homeownership Program for Section 8 families, a joint project with Rochester Housing Authority's Leasing Operations Department and Family Investment Center, in which qualified families receive monthly mortgage assistance payments from RHA and homeownership counseling and education from Providence.
- Counseled 150 income eligible families on **credit repair** and **homeownership**.
- Leveraged \$2,294,700 in affordable mortgages.

### Offering shelter and care

- Provided rent subsidies and case management services to 55 homeless persons, and their families, in the County of Monroe under the Shelter + Care program.
- Provided housing counseling assistance to 75 families that will be displaced by the expansion of the Greater Rochester International Airport in 2002.

## Managing quality communities

- Assumed management of Mt. Carmel Housing, 12 apartments for formerly homeless and extremely low-income families, for the parish of Our Lady of Mt. Carmel Church.
- University of Rochester students and Nazareth Academy students helped beautify West Town Village, Union Meadows and Mt. Carmel Housing by planting, weeding and painting during Wilson Days and "Works of Love."

## Collaborating with Catholic Charities and others

• Held a day-long workshop for Catholic Charities and others on the "ins and outs" of funding housing development.

# Awards

- Executive Director Maggie Bringewatt's name was inscribed on the McAuley Institute's permanent roster of courageous women for her work to bring social justice to housing issues in the United States.
- A Project Award from the Rochester Chapter of Construction Specifications Institute was made to West Town Village Senior Apartments for exceptional architectural specifications and drawings realized through teamwork between contractor, architect and owner February 24, 2001.
- The 2000 Historic Preservation Award 1<sup>st</sup> Runner Up was given to the restoration of the Geneva YMCA Building (now Elizabeth Blackwell Apartments) May 16, 2001.
